PE & SPORTS GRANT – ACADEMIC YEAR 2022 - 2023

STATEMENT

Most schools with primary-age pupils receive the PE and sport premium in the academic year.

Purpose of Funding (taken from DfE website)

Schools must use the funding to make additional and sustainable improvements to the quality of PE and sport you offer.

This means that you should use the premium to:

- develop or add to the PE and sport activities that your school already offers
- build capacity and capability within the school to ensure that improvements made now will benefit pupils joining the school in future years

There are 5 key indicators that schools should expect to see improvement across:

- the engagement of all pupils in regular physical activity - the Chief Medical Officer guidelines recommend that all children and young people aged 5 to 18 engage in at least 60 minutes of physical activity a day, of which 30 minutes should be in school
- the profile of PE and sport is raised across the school as a tool for whole-school improvement
- increased confidence, knowledge and skills of all staff in teaching PE and sport
- broader experience of a range of sports and activities offered to all pupils
- increased participation in competitive sport

Intent

Girlington Primary is part of CAS – Creating Active Schools. The CAS Framework supports schools to embed physical activity in policies, systems, behaviours and environments, so that it becomes everyone's responsibility; from pupils, to staff, parents and governors.

Girlington Primary Schools intention is to develop the whole school philosophy of whole child, whole day to provide to increase physical activity across the whole school.
